Members of the Napa County Bar Association:

We're now several months into the coronavirus pandemic, a situation that has significantly impacted all our personal and professional lives. Here at the Court, we've taken great strides in implementing health and safety protocols to provide a safe environment for attorneys, litigants, our staff, and the public.

Some examples of these efforts include a mask/face covering requirement when inside facilities, hand sanitizer stations in public areas and courtrooms, social distancing signage and floor markings, as well as sneeze guards installed in clerks' offices and at witness stands. We have also rolled out remote video appearances in every courtroom, as well as self-help and mediation services, with the goal of reducing foot traffic within the courthouses.

Given the unrelenting march of the virus, the Court is taking additional steps to further reduce inperson interactions. The next phase will include the implementation of mandatory remote appearances in several calendars starting next week. These calendars include:

Moving forward beyond these calendars, the Court is taking additional steps to implement case processing efficiencies and expand access to proceedings. This includes assessing the viability of e-filing in criminal and juvenile delinquency matters, digitizing plea forms, allowing for remote appearances in evidentiary hearings, and rolling out audio streaming in designated calendars. We'll be sharing more information on these efforts soon.
